Public comment is offered in a spirit of open communication and the organization being receptive to new ideas and constructive suggestions. The Chair of the meeting may adopt a flexible approach in allowing public comment but will not tolerate personal attacks and/or indecorous behavior.

Procedures for the formulation of the member meeting Agenda: (standing rule #9)

- A. Every meeting of the membership shall have a written agenda
- B. The agenda shall consist of:
 - 1. Standing Items
 - 2. Old Business
 - 3. New Business
- C. Standing Items shall be items which either the general membership and/or board resolves at a prior meeting be placed upon the agenda at subsequent meetings.
- D. Old Business shall be items of business from previous meetings which shall not have been concluded and shall be added to the agenda by the Board President.
- New Business items shall be items not being either standing items or old business which it shall be in the purview of the membership to discuss. New business items shall be added to the agenda by the Board President, the board or by any three general members.
- Items of new business may be added to the agenda if communicated to the Board President in writing fourteen days prior to the published date of the meeting. Communication may be in the form of a letter and where an addition is being proposed by three general members each must sign a letter requesting such addition.
- G. No item(s) shall be added to the Agenda at the meeting.



Consensus Model for Decision Making:

Standing Rule #8, All Board Meetings shall use the following consensus model for decision making:

When it appears that the group is nearing consensus or when a voting member has asked that the group move to consensus, the facilitator shall ask:

- 1. Is there any further discussion?
- 2. Are there any objections? (Does anyone wish to stand aside?)
- 3. Do we have consensus?

A voting member may only block consensus if s/he has an alternative suggestion. If the alternative also does not produce consensus, another motion must be presented, or the issue must be dropped/tabled. If an individual cannot support the consensus statement but does not wish to block consensus s/he may stand aside. The objections shall be noted in the minutes. Friendly amendments can be offered (if appropriate), though the person who initiated the motion is not obligated to accept them.

If a tabled issue is still at an impasse at the following meeting, a voting member must make a motion on which the group will vote. The motion requires a simple majority to pass (unless otherwise noted in the by aws). If an issue is at an impasse and is time sensitive (i.e., it cannot be tabled to a future meeting), a voting member must make a motion on which the group will vote. The motion requires a simple majority to pass (unless otherwise noted in the bylaws).

The consensus model shall use the following ground rules:

- 1. Participants should not speak out of turn. The facilitator will recognize hands in the order in which they were raised. Those who have not spoken on an issue will be given the option to do so before anyone speaks a second time.
- 2. Comments should be brief, respectful, and relevant to the topic being discussed. Participants should avoid repetition and focus on closure.
- 3. The facilitator shall put time limits on the discussion and choose a timekeeper. The time for discussion can be extended by group consensus.
- 4. Participants should accept decisions with which they can live to avoid debating minutia.
- 5. When appropriate, the facilitator may call a break in the meeting to allow the person blocking consensus and the person initiating the motion to try to work out an alternative together.
- 6. Everyone is equal.
- 7. Derogatory personal comments are inappropriate.
- 8. In groups of 20 or more, the decision-making process uses a modified form of consensus. An individual who blocks consensus must still offer an alternative. One alternative may be a suggestion to use Robert's Rules of Order to resolve the issue under consideration. If the group (less the block) rejects the alternative, the group may then resolve to override the block for a "modified consensus minus one." If two individuals block consensus, the standard form of consensus shall be used.

It is a good idea for someone to read these rules aloud at the beginning of a meeting, especially when new people are present. All Board members should receive training in these rules at the Board retreat.

VIII. Reports

- A. President Has been mostly working with Fred to go over the Freedom Day event, though it is currently postponed. Thanked Fred and Pete for all their work as we juggled the difficulties of putting out a statement. Thanked the Board for their input, this will likely be challenges we face in 2022, with the pandemic and plans. Carolyn was appointed to the National Federation of Democratic Women, where she also serves on the California iteration. Thanked Elizabeth for being with her at the Dykes on Bikes Anniversary celebration, spoke about the importance of having the DOB participate at Pride Movie Night at Oracle Park.
- **B.** Vice President Expressed concerns that issues within her family have kept her less involved the last month, but she assures us that she is stepping back up.
- **C.** Treasurer No report. Jim submitted fiscals, usually it is difficult to get them at the 1st of the month. Joshua asked if we could please get the Treasurer's Reports missing from previous months. Suzanne confirmed that all the numbers needed for a Treasurer's Report is in Jim's financials. Joshua asked if Fred could make sure we get this taken care of moving forward.
- **D. Secretary** Thanks to all colleagues for your partnership this past year. Looking forward to next month and year.
- E. Executive Director Written, attached. Fred went over the details in it. Including the AGM election info, and the Ken Jones Award Ceremony. Manuel asked if, for the future, we do this event in the Mission, make sure we engage the Latinx community, and Joshua suggested also the Womens' Community. Elizabeth asked if we needed to register for the AGM, Fred explained how the Zoom greeting room and meeting room entry would work, and is also posted at members.sfpride.org.

- Policies & Procedures Manuel reported we have concluded our eight-month (it's
 actually been a year and eight months!) journey and thanked the Board and Staff for
 their participation. Included a link where all the changed and approved documents exist.

 and H as they have updates.

 - Community Affairs Joshua related CAC is on a little break during September while we focus on the AGM. Will return in October with guests to help celebration International Latinx Hispanic History Month (starting Sept. 15th). Thanked Lady Diana and Bivett for their work during the last year. Previous Member meeting got good feedback, but a bit long with three speakers, so cutting back to two. Member Mixer concept is on hold until pandemic issues resolve. Maybe the CAC could do a strategic retreat-style gathering to go over the year ahead for Member meetings, work with Community stages. Thanks to RJB and Elizabeth for attending the CAC meetings, too.
 - Audit Nguyen said, this month expect a draft report to review.
 - **Development** Elizabeth said no report, but Suzanne had a golf event report. Sponsor pledges are about \$40K. Friday night, award reception at Beaux, need set up help, contact Nguyen and Suzanne. Need people to sit at 13th hole, for hole in one possible winner for BMW car prize donated by Weatherford BMW. Giving award out to out pro golfer Tadd Fujikawa. Trans pro golfer Hailey Davidson will also be attending. Elizabeth added we need to discuss with Beaux about issues surrounding mistreatments.

A. Inaugural Annual Awards Ceremony – Rachel ran over a bunch of the planning details so far, with info about Hilton set up. Decisions need to be made soon. We will need a vaccination policy for folks attending. Some date changes due to Freedom Fest cancellation. Thursdays might be a good day to have an event. Silent auction, partner tickets, general ticket sales (with membership discount) are revenue generators. Showed us a spreadsheet

of expenses. Then predictions of ticket income. Joshua asked if partner tickets addressed free tickets. Fred said no, this is a fundraiser, Rachel confirmed no comps. Elizabeth said that, in comparison to other, similar events, these prices are good. Anjali – maybe a ticket price which includes food costs can be higher? Carolyn said that, based on experience from events held there before, the way food is served would make this a logistical nightmare, although perhaps we could wristband and then hotel staff would need to monitor that. Suzanne thinks we can elevate the prices a bit more (\$50 and \$75) — challenges the rest of the Board to sell 10 tickets each. Fred says we could consider raising them to \$50 and \$65 maybe. Early bird vs. regular time. Marketing, shortness of time, team (staff and Board) would need to push tickets. Looking at Thurs. Oct 7th or 14th, or another day. Anjali now suggests \$75. Suzanne prefers October 14th, Manuel, tough to do work nights, are there other ways that we don't raise prices/reduce income – bundle tickets to organizations? Fred reminded us that this is not a large capacity event, so our options are also limited. Manuel expressed concern that our historically targeted folks cannot access the event but are invited in as entertainment (and the optic that creates) creates an accidental dynamic. Rachel cited the Chinatown Pride celebration doing similar options in summing up her presentation.
